IMPORTANT JUDGEMENTS

SUPREME COURT OF INDIA

- Conveyance is not part of wages for ESI contributions.
- Dismissal for forging education certificate when admitted, acquittal in the criminal case will be irrelevant.
- High Court should not interfere in awarding punishment being the prerogative of the employer.

MADRAS HIGH COURT

- Non-payment of retrenchment compensation at the time of termination would justify reinstatement.
- During pendency of review application, issuance of recovery notice is not sustainable.
- Waiver cannot be granted against interest imposed under section 7-Q of the Act.
- Appeal filed beyond the maximum limitation period of 120 days, is not admissible.

CALCUTTA HIGH COURT

- EPF contribution cannot be misappropriated after the deduction of employees' shares.
- Proceedings under section 7A to be set aside when the opportunity to produce evidence was not given to the employer.

IMPORTANT JUDGEMENTS (CONTD.)

MADHYA PRADESH HIGH COURT

- Service condition of workman can't be changed during pendency of industrial dispute.
- An inquiry violative of natural justice is to be vitiated.





IMPORTANT JUDGEMENTS (CONTD.)

KERALA HIGH COURT

- EPF dues in installments may be allowed considering the financial difficulties of the employer.
- EPF Authorities are supposed not to issue notices in a mechanical manner to the employers.

GUJARAT HIGH COURT

- Modification of punishment of dismissal for theft would not be proper.
- Relationship between employer and employee will not establish when no witness is produced.
- Tribunal can differ with the conclusion of disciplinary authority only for justifiable reasons.
- Interim relief restraining the EPF Authority from taking coercive steps will operate till the Tribunal hears the petitioner.

NOTIFICATION-DECLARATION OF "EPF ROI" FY 2021-2022

The Employees' Provident Fund Organization declared 8.10% as the rate to credit interest to the account of each member of the Employees' Provident Fund Scheme, 1952, for the year 2021-22. View Notification

NOTIFICATION-EXTENSION OF THE ESI ACT

The ESIC extended the provisions of the Employees' State Insurance Act, 1948 w.e.f 01-June-2022, to certain classes of establishments and areas in which the establishments are situated provided in the Schedule of the notification. View Notification
