

MINIMUM WAGES REVISION - KERALA

The Government of Kerala, Labour and Skills (E) Department has revised the variable dearness allowance for employment in Shops and Commercial Establishment and employment in Computer Software Sector. As per the Notification, the Consumer Price Index (Cost of Living Index) Numbers applicable to employees in employment under the Minimum Wages Act (Central Act XI of 1948) for the month of May 2023 ascertained by the Director General of Economics & Statistics under clause (C) of Section 2 of the Act. **View Notification**



Exemptions Under The Karnataka Tax On Professions, Trades, Callings And Employments Act, 1976 – KARNATAKA

The Government of Karnataka has exempted certain class of person from payment of tax under The Karnataka Tax On Professions, Trades, Callings And Employments Act, 1976. <u>View Notification</u>












IMPORTANT JUDGEMENTS



ALLAHABAD HIGH COURT

• Tribunal is empowered to waive or reduce pre-deposit conditions for admission of appeal. View Judgement • Time spent on litigation on writ petition may be considered for limitation in filing appeal. View Judgement

BOMBAY HIGH COURT

- Principal employer, not contractor, is liable to pay EPF dues. View Judgement
- Attachment of bank account to be released to enable the petitioner to deposit 50% of due amount. View Judgement • EPF dues can be released in favour of nominee in view of affidavit and proofs by the legal heir of the deceased. View Judgement • Liability of payment to EPF dues only when determined u/s 7-A of the Act. **View Judgement**





CORE **IMPORTANT JUDGEMENTS**



CALCUTTA HIGH COURT

- Common chartered account of two firms shall not club two independent establishments. View Judgement
- Clubbing of two independent firms having separate Permanent Account Numbers and bank ac-counts is not proper. View Judgement

CHHATTISGARH HIGH COURT

•Number of defaults, period of delayed deposits would be relevant for imposition of damages for delayed deposit of PF dues. View Judgement

GUJARAT HIGH COURT

• Back wages denied on reinstatement if workman is gainfully employed. **View Judgement**


DELHI HIGH COURT

• Coercive action for recovery can be stayed as interim protection by the High Court. View Judgement





IMPORTANT JUDGEMENTS



GAUHATI HIGH COURT

- Ex-parte award is to be set aside based on ipse dixit. View Judgement • Quantum of punishment is to be considered by the Labour Court in its award. **View Judgement**
- Failing to give opportunity to employer to produce evidence when inquiry is vitiated would nullify award of the Labour Court. View Judgement


JHARKHAND HIGH COURT

- Criminal complaint untenable if company not made an accused along with General Manager under CL(RA) Act. View Judgement • Any order passed by EPF authority u/s 7-A without identification of beneficiaries is not sustainable. View Judgement • Aggrieved employer can file review of appeal before the Tribunal against order
- u/s 7-A View Judgement





IMPORTANT JUDGEMENTS



KARNATAKA HIGH COURT

Principal employer will not have any relationship of employer-employee with workers of a contractor. <u>View Judgement</u>
Gratuity can't be claimed under Industrial Disputes Act. <u>View Judgement</u>
When two courts have jurisdiction for adjudicating a dispute, parties can choose one forum. <u>View Judgement</u>
Dismissal of a driver justified causing accident, remaining absent and misappropriation of money of the corporation. <u>View Judgement</u>
On failing to seek approval, dismissal will be non est. <u>View Judgement</u>
For forfeiture of gratuity, procedure under section 4(6) of the Gratuity is to be followed. <u>View Judgement</u>


KERALA HIGH COURT

Maternity benefit will be available to an employee even on contract basis.
 <u>View Judgement</u>

MADHYA PRADESH HIGH COURT

Acceptance of resignation by incompetent authority is illegal. <u>View</u>

Judgement

Medical representative will not be workman under Industrial Disputes Act.

EPF authority u/s 7-A is vested with the power of Civil Court. <u>View</u>
 <u>Judgement</u>


MADRAS HIGH COURT

 An order passed by EPF authority to be quashed when documents in files are not considered. <u>View Judgement</u>

Belated deposit of ESI contributions will attract interest. <u>View Judgement</u>

Supreme Court of India

 Dismissal justified when proper enquiry is held in the charge sheet issued to the workman. <u>View Judgement</u>





EGRA IMPORTANT JUDGEMENTS



RAJASTHAN HIGH COURT

• Privileged leave cannot be claimed by an employee as a matter of right. **View Judgement**

• An employee is bound to comply with her transfer. View Judgement

TELANGANA HIGH COURT

• Penal damages will be justified if default in remitting the EPF dues. View

Judgement

- Appellant must get copy of the order by Appellate Tribunal. View **Judgement**
- Dismissal of appeal in default untenable if no date is mentioned for nonappearance. View Judgement


